Title and abstract of PhD thesis (within 150 words)

"Obligations of the applicant in accordance with the provisions of the law of Moroccan obligations and contracts and comparative law"

A deposit under which a person surrenders something transferred to another person who is committed to his custody and his own return. In accordance with Chapter 781 of the Moroccan Obligations and Contracts Act. The deposit shall be effected by the consent of the contractors and the disposition of the deposited object. Delivery shall be made by mutual consent if the object is otherwise in the hands of the applicant in accordance with Chapter 778 of the Moroccan Contract Law.

And the original in the deposit shall be unpaid, but the applicant shall be entitled to a wage if he has expressly stipulated it or has appeared in the circumstances of the case or knew the place that the contractors have implicitly given the grantor a certain wage and this presumption is legal if he normally receives the remuneration on the basis of Chapter 790 of Moroccan law of obligations and contracts.

It is clear from the foregoing that the properties of the depositary contract in the Act mentioned that it is my eyes, and is given to the movables, and that it is binding on one side of the donation contracts, and it is a temporary contract.

In this contract, the applicant shall be bound by a primary obligation to preserve the object and its specific return.
