English / Title :

"The Termination of International sale contract of goods in the 1980 vienna sales convention".

Our research in the termination of international sale contract of goods is in accordance with the 1980 Vienna Sales Convention . It is important ,in this Convention , to distinguish between the bilateral termination and the unilateral termination of international sale contract of goods . In fact , our research is subdivided in two parts . The first one is devoted to the bilateral termination of international sale contract of goods . In this part , we examine the qualification of bilateral termination , the application of the 1980 Vienna sales convention to theis bilateral termination , the formation and the validity of this bilateral termination , and finally the question of transfer of rish (passing of risk) . In the second part of our research , we define the unilateral termination of international sale contract of goods by studying the cases of this unilateral termination in case of non-performance which is attributable to the non- performing party , the distinction between the fundamental breach of contract and the non-fundamental breach of contract , and lastly the effects of the unilateral termination : restitution of the goods ; restitution of the price ; damages; exemption from the liability when the non-performance is attributable to an act of God or to an act of aggrieved party .
