#### The law school Wins The Moot Competition 2015

The Faculty of Law of the University of Jordan has recently participated in the National Mood Court Competition of 2015, which was organized by the NGO Rasheedin cooperation with the Jordanian Judicial Council. Three other universities joined the competition this year as well as the University of Jordan; The Petra University, The University of Al-Isra'a and The World Islamic Sciences and Education University.

The subject matter of the case of the competition for this year was relating to the crime of vote-buying, and the conditions of membership in the Jordanian House of Representatives.

The Faculty of Law at the University of Jordan participated in the competition with two teams under the leadership and supervision of Dr. Laith Nasrawin, the Associate Professor of Constitutional Law. The first team consisted of Aya Club and Rania Naber, and the second team consisted of MouhjaMouhaisen and HadeelMughrabi. The second teamhas successfully won the competition after putting a wonderful performance which attracted the admiration and praise of all judges. They passed the second team of the University of Jordan in the first stage, and thendefeating the team of Petra University in the semifinal, before beating the team of the World Islamic Sciences and Education University in the final to win the cup of the competition

This is the second time the School of Law wins this competition. In 2012, the law school took part in this annual competition and succeeded in defeating all other teams and be crowned the champions.

#### The Dean of The Faculty of Law Meet Expert from The WIPO



The Price Media Law Moot Court Programme was established in 2008 with the first International Rounds in Oxford in order to foster an interest in international law governing freedom of expression issues.
