Title: Public guarantees related to arrest: Comparison between French and Jordanian law Abstract: The issue of (legal guarantees for a person arrested by the police) is considered one of the most important controversial issues in French and Jordanian laws, since arrest is a measure depriving liberty before trial. Therefore, it must be surrounded by severe procedural guarantees, and the arrested person should enjoy effective rights, in addition to subjecting the arrest to supervision severe. The main objective of studying this subject is how can we, through these legal guarantees, achieve a balance between the public interest to reveal the truth when the accused person is arrested and the personal interest of the arrested person by guaranteeing his rights and a fair trial. In comparison between the Jordanian and French law, we find that the French law has witnessed a remarkable development in this regard thanks to the European influence, which aims towards a fair

trial, although there are still some legal gaps that need to be addressed. As for Jordanian law, it is still modest in its progress in dealing with guarantees of arrest in the Code of Criminal Procedure, especially with regard to the rights of the arrested person. Therefore, it is worth benefiting from the French experience in dealing with the subject of guarantees of arrest in Jordanian law.
