The liability for the acts of others

« a Comparative Study in Jordanian and French civil laws »

The non-contractual liability for the acts of others presumes the existence of four elements: damage, generating act, link of casualty and the authority of direction.

The Jordanian and French civil laws extend widely the liability for the acts of others resulting from breach of obligation of surveillance. We have to mention here that despite the fact that the Jordanian legislator had created, since 1976, a general principle which applies to natural or judicial persons who are under a legal or contractual obligation to supervise another person in need of supervision due to his minority or his mental or physique condition, it is only from 1991 that we could start talking about a similar principle in French Law.

However, if in the French Law, the general responsibility for the acts of others mentioned in article 1384 paragraph l, is an objective responsibility, we regret that the

Observer's liability, in Jordanian law, is based on the assumption of fault.

In a parallel way, both of Jordanian and French Laws know a special form of responsibility concerning the employers for the acts of their subordinates. It seems to be an objective responsibility which is based on the effective power of controlling and surveillance. This responsibility is subject to similar provisions in the two laws.
